### **FREEDOM OF INFORMATION REQUEST ULTIMUS HAERES - IVAN WERHUN**

Thank you for your email of 18 July in which you asked, under the Freedom of Information (Scotland) Act 2002 for further information this office may have with regard to the above named individual whose intestate estates is being administered by the QLTR Office.

You ask for information which may help you locate the deceased's place of birth and his family. In particular, if we hold information re his religion, names of his family members, past addresses and place names, such as the exact town of birth, or places where the family resided in the Ukraine & Poland.

I can advise that additional information held re this estate which may be of assistance to you is that he is noted as being born in Pakist, Ukraine. We hold an extract copy of his birth certificate for which we enclose a copy. I can also advise that he is believed to have a sibling in Lviv, Ukraine. He arrived in the UK on 19 June 1947 from Italy. His first place of residence was CVW Camp, Amisfield. I list below the places he appeared to reside after CVW Camp, Amisfield which we only have information to up until late 1956:

If you are dissatisfied with the way in which your request has been handled, you do have the right to ask us to review it. Your request should be made within 40 working days of receipt of this letter and we will reply within 20 working days of receipt. If you require a review of our decision to be carried out, please write to The Disclosure Section, Policy Division, or for requests sent by e-mail to [foi@copfs.gsi.gov.uk](mailto:foi@copfs.gsi.gov.uk)].

The review will be undertaken by staff not involved in the original decision making process.

If our decision is unchanged following a review and you remain dissatisfied with this, there is a right of appeal to the Scottish Information Commissioner under section 47(1) of FOISA.

Should you subsequently wish to appeal against the Commissioner's decision on such an appeal, there is a right of appeal to the Court of Session on a point of law only."
